



## 234 Los Angeles Children To Be Adopted on National Adoption Day Adoptions represent notable progress on the eve of important foster care reforms in California

**Los Angeles (November 15, 2016)**—On National Adoption Day Friday, November 18<sup>th</sup>, 2016, at 12:30 pm the Alliance for Children's Rights and its local partners, Public Counsel, DCFS, and the Los Angeles Juvenile Court, will celebrate the adoption of 234 Los Angeles children from foster care at the Edmund D. Edelman Children's Court. The day will begin with a press conference, followed by adoption proceedings at 1:30 pm.

This year, the celebration of National Adoption Day has special significance for California, as the state has undertaken dramatic reform to move children out of group homes and into nurturing families with new legislation that takes effect January 1, 2017. The success of these reform efforts depends on more members of our community stepping up to provide homes for abused and neglected children in foster care who cannot return to their biological parents. In publicizing the 234 adoptions taking place on November 18<sup>th</sup>, we hope to draw attention to the great need for foster adoptive families.

In the past, older children often languished in foster care. This year, at Los Angeles National Adoption Day, more than half the children being adopted are over the age of 6, and 27% are over the age of ten, a fact that represents progress toward the goal of helping every child in the child welfare system find permanency and stability so that they can thrive.

National Adoption Day was founded by the Alliance for Children's Rights in 2000 with the support of the Dave Thomas and Freddie Mac Foundations. The project began as a solution to the overwhelming number of adoptions that were stuck in a backlog in the court system. Together, the Alliance and its partners cleared the backlog and established a national pro bono model for expediting pending adoptions.
